Report on Annual General Meeting

Friday 20th, September, 1963

TREASURER'S REPORT

Mr. Bradstreet said that last year there was a deficit of £47. At that time he predicted that we should break even during the next year and it was most gratifying that we had done better than this and had in fact a surplus of £12 14s. 6d. He thought that the balance sheet showed a healthy situation. The income of £59 9s. 2d. from subscriptions was a record and reflected great credit on the collectors, Mrs. Jones and Mr. Bond, who collected subscriptions from 1,460 members. All the advertising space in the *Journal* was taken throughout the year. The Treasurer ended wih an expression of thanks to the auditors. The adoption of the report was unanimous. (see page 15).

CHAIRMAN'S REPORT

Mr. Pike first extended a warm welcome to Councillors Fletcher and Stewart and was pleased to be able to welcome County Councillor Ratcliffe for the first time. Mrs. Thubrun, the other Ward Councillor, was now the Mayor of Hendon and had sent her apologies for not being present.

ROAD SAFETY

Last year he said that he mentioned the request for a Crossing Patrol outside Frith Manor School. It was now clear that since the Police could not see their way to provide such a patrol, the efforts of the Association and others had been unsuccessful. They did, however, have an assurance from the Police that they would continue to watch the situation.

PROPOSED LIBRARY

The Council had told us that a branch library would be erected alongside Riverside Walk and was expected about 1966-7. A request that a public convenience be provided at Sussex Ring had elicited a reply that this would be part of the public library scheme. He hoped that these plans would not be upset by the coming of Borough 30.

CIVIC CENTRE

Our views on the Civic Centre had been expressed in the *Journal*. It must be regarded as unfortunate that the plan for the Centre was launched at the same time as the plan for Borough 30. It might appear from this that Hendon was trying to centre the activities of the new borough in their particular area.

THE EFFECTS OF THE WINTER

Complaints had been received concerning the poor condition of the roadway to Woodside Park Tube Station. Difficulty was still experienced concerning the owners of the road, but it was good to note that the road had recently been resurfaced. Soon after the snowstorms the brook became clogged up with much debris hindering the flow of water. Following a letter from the Association to the Middlesex County Council, the authority responsible, prompt action was taken.

GREATER LONDON PLAN

On this matter the Journal had contained a good deal of information, but there seemed still to be apathy not only on this estate but amongst Londoners in general. It appeared that until something happened the realities of the plan would not be brought home. This Association has been much concerned with the plan and its implications were discussed at the last A.G.M. The choice of name of the new Borough 30 has been causing some concern. A joint Committee had been set up and had chosen the name Barnet on a vote in which there was a 4 to 1 majority. The Chairman wondered whether members of the Association had any views. The Committee had thought that there was merit in choosing an entirely fresh name such as Northgate. A new administration should have a new name. He understood from the Ministry of Housing and Local Government that the Minister had accepted the name Barnet but in view of the way in which the name was chosen had asked the joint Committee whether they wanted a second thought. The Minister feels that further discussion might be appropriate. Presumably the joint Committee will now discuss the matter. It is to be noted that the Post Office do not intend to change their boundaries or districts. Hence troubles arising from the use of addresses such as Woodside Park, Hendon, will continue to arise.

MAINTENANCE OF HIGHWAYS, ETC.

The Chairman said that it is sometimes thought that the Ratepayers Associations exist to stir up trouble and take the view that all the actions of the Council are wrong. We do not take this view in conducting the activties of our Association. We feel that the Association provides a very useful avenue of contact with the Town Hall. The Association always took advice and suggestions from the Ward Councillors.

In spite of the above he would like to conclude by criticising one aspect of the Council's activities. The matter may be considered trivial but it may none the less be important. After the snow and during it, his phone continually rang with people complaining about the failure of the Council to clear the roads. People had the feeling that Woodside Park on the outskirts of Hendon was always forgotten. We made our views known in the Journal and in particular suggested that the Council purchase more equipment. He was glad to note that this is now being done. It seems, therefore, that Hendon will not again be caught napping. When the snow eventually went there was much work left to be done. He would like to ask whether people considered that the day-to-day maintenance work carried out on paths, roads, street furniture, verges etc. was satisfactory. He considered that in general the maintenance of the roads was satisfactory, but on other matters he was not happy. However well you keep your house, when you come to sell the price will depend in part on the way grass verges, pavements etc. outside are kept. The Ministry of Housing has recently sent a circular to all Councils concerning name plates, their design and siting. Our standards fell well below the circular. We note that the grass verges are cut but the edges are hardly ever trimmed. Such things reinforce the idea that Woodside Park is out of the orbit of Hendon. The pavements are in a bad way although not as bad as they were during the snow. One of the troubles seems to be that there is a shortage of the right type of labour and that supervision of such labour leaves much to be desired. Let us hope that Woodside Park will feature prominently in the future Committee Room and Council Chamber discussions.

Election of Officers

There being no further nominations and all the present officers being prepared to serve they were re-elected.

Election of Committee Members

There were two vacancies on the Committee through the retirement of Miss Day and Mr. Farrow. Two nominations had been received in the names of Mr. S. T. K. Hester and Mr. B. J. H. Strachan. It was proposed that all 10 names be put en bloc. This was agreed and they were elected.

Election of Auditors

Mr. A. F. Lewis and Mr. M. E. Robinson were re-appointed.

Honorary Membership

The Secretary spoke on the Notice of Motion that the rules of the Association be changed to allow for the election of Honorary Members as a mark of esteem. Mr. English seconded the adoption of the proposal and it was carried unanimously.

Discussion on the Chairman's report

The Chairman suggested that since we had 3 Councillors present members might like to ask them questions about the implications of the Greater London Plan.

In reply to a question Councillor Fletcher said that there would be two elections next year. In April 1964 we would have elections for the Greater London Council (G.L.C.) and in May 1964 there would be elections for Borough 30. The present Hendon Council and the Middlesex County Council (M.C.C.) would remain in office until April 1965. There would therefore be one year during which both Borough 30 and Hendon Council would exist.

There would be 4 candidates to be voted for Borough 30. The Borough will at first be considered as a whole but by 1967 it would presumably be split up and there would be one member constituencies. For the G.L.C. there would be one member of the Council for North Hendon, one for South Hendon, one for Finchley and one for Barnet. The Chairman pointed out that no matter what name was chosen for the new Borough the names Finchley, Woodside Park etc. would, of course, continue. He suggested that people were more concerned with the likely rates to be levied under the new scheme rather than its name.

A member asked about the County Precept. He said that in the last rate demand this seemed to be lower than usual, and was it true the M.C.C. were dissipating their reserves—Councillor Ratcliffe said that this was so; they took the view that the money had been collected for the M.C.C. and not for the whole of London. However, the reserves only represented a small proportion of the total expenditure. Therefore it was true that the G.L.C. would probably have to levy a higher rate to start with since they would have slender reserves. However he did not think they would affect the rates by more than about 5—10%. Councillor Fletcher said that Hendon did not take more than usual out of their balances this year. All Councils will go into the new arrangement with as small a balance as possible. It was, however, difficult to determine how the rates would be affected by the (continued on page 14)

THE PEOPLE AROUND US

5. THE IMPERIAL CANCER RESEARCH FUND LABORATORIES IN MILL HILL

THE Imperial Cancer Research Fund was established in 1902 and was one of the very first organisations in the world to undertake

experimental cancer research in its own laboratories.

The original laboratory was provided by the Royal Colleges of Physicians, and Surgeons and was situated on the Victoria Embankment. In addition the Fund acquired in 1903 the lease of a farm near Cuffley where animals suffering from cancer might be kept under observation.

In 1912 the laboratories were moved to Queen Square, Bloomsbury and here the work was continued for more than 20 years. The lease at Cuffley terminated in 1923 and arrangements were then made with the Medical Research Council to occupy a portion of their ground on the Ridgeway, Mill Hill. Here the Stroud Laboratory was built to replace the old farm and to provide laboratory space for work on chicken cancer and on the cultivation of tissues outside the body tissue culture.

Ultimately the total laboratory accommodation became inadequate

and new arrangements had to be made.

The Fund, in March, 1936, acquired from the Medical Research Council the lease of property situated in Burtonhole Lane, about 300 vards to the east of the original Stroud Farm and adjacent to what is now the National Institute for Medical Research. The laboratories on this site were officially opened on June 27th, 1939.

In addition to the main block which housed a library, offices and workshops, as well as laboratories, there was a large animal house for the breeding of pedigree mice, guinea-pigs and rabbits; a smaller house intended for larger animals such as goats and pigs; and two staff houses.

Eleven Associations form the New Federation

DELEGATES from ratepayers' associations covering the whole area of the proposed new London Borough 30 met at the Hendon Town Hall on the 27th September. At this meeting it was agreed in principle to form a Federation of Ratepayers' Associations to face the problems which will undoubtedly arise from the emergence of such a vast local authority.

The meeting was presided over by Mr. J. Harley, J.P., and Alderman K. Pamplin, Mr. R. H. Williams Town Clerk of Hendon and Mr. W. R. Harman, Borough Treasurer of Finchley addressed the meeting. The many problems inherent in the proposed amalgamation of the five authorities were explained by Alderman Pamplin. A Joint Consultative Committee had been meeting for several months and on this committee and its various sub-committees there was equal representation.

Mr. Williams told delegates the whole story of the Royal Commission's report on Local Government and how, in his opinion, local government would have ceased to exist in its present form in the very near future. The merging of the five councils would in the long run allow more economical working than the separate councils enjoyed at the moment. Mr. Williams then explained how the new borough would come into being with elections next May and that it would work alongside the existing councils for twelve months. At first there would be a Chairman of the new borough and the first Mayor elected in 1965. The composition of the new Council was mentioned by the Town Clerk and he answered many questions from delegates.

Expecting questions on rates to be put to him Finchley's Borough Treasurer Mr. W. R. Harman began his talk by stating that he was not in a position to forecast the rate likely to be fixed by the new council. Speaking on the financial side Mr. Harman said that there would be a considerable transfer of services such as refuse disposal being taken over by the Greater London Council and education being the concern of local boroughs. The new borough would have a rateable value in the region of £21 million. A penny rate would produce some £85,000.

Each speaker gave his personal views on the choice of name which is expected to be Barnet. There was apparent disagreement in several council chambers as to names submitted to the Minister of Housing and Local Government but obviously a name to please everybody would be impossible to find.

Many questions were put to the speakers. The Chairman and Treasurer together with Committee Member Mr. V. J. J. English represented this Association and delegates were also present from the ratepayers associations of Barnet, East Barnet, Edgware, Finchley, Friern Barnet, Golders Green, Hadley, Hendon, Mill Hill and Totteridge. A formation committee was elected and will meet shortly to elect officers and committee and to discuss rules and constitution.

The work in these new laboratories was much curtailed by the Second World War and, in the expansion of the post-war period a separate clinico-pathological unit was set up in Lincoln's Inn Fields close to the Royal College of Surgeons building, some of their labora-

tories being indeed, used by the Fund.

The next development followed the appointment of Dr. G. F. Marrian, F.R.S.—the present Director of Research of the Fund—in 1958. A large, new laboratory was built in Lincoln's Inn Fields. This opening in September 1962 and was visited by the Queen and the Duke of Edinburgh in June, 1963. Most of the Fund's research is now concentrated there but one of the Divisions—Experimental Biology and Virology—has remained at the Mill Hill Laboratories under the direction of Dr. R. J. C. Harris. These have been extended so that new workshops and extra animal breeding facilities—and a tennis court—could be provided. A new, temporary laboratory has also been built for studies with radioactive materials.

During the war a group of garages was erected in front of the building to meet storage problems. These were not decorative (!) and we are glad to say that it has proved possible to remove them

entirely this year.

Most of the sixty or so who work there live in the environs and there is not one of them who does not feel that it is a privilege to be able to do this in the quietude of the laboratory in Burtonhole Lane with its incomparable view over the valley.

larger Boroughs. How would the average rate work out in Borough 30 compared with the present Hendon rate. Other complications were the Rate equalisation schemes to see that there were not great differences over the whole G.L.C. area. Then there were transitional rate equalisation schemes to see that the rates of any one area were not changed too much. Finally the Government may decide on a different method of financing some things which were at present paid for in part by the rates.

When the Chairman closed the discussion Mr. Farrow rose to thank him for conducting the meeting and said he had enjoyed being a member of the Committee and was glad that he still lived in Woodside Park and had the benefit of such an active Association.


Christmas Tree Arrangements







