Council News - a report from Councillor Brian Coleman

The months of work on the draft Council budget for 2003/4 came to a conclusion when the budget headlines were announced at a Council Policy Conference on December 17th. Barnet - having been placed on the "floor" in government grant terms along with en other London boroughs, and the borough's reserves having been spent by the last administration - is facing a Council tax rise of 26 per cent, on top of which has to be added Ken Livingstone's rise. New Government arrangements on how much money has to be directly "passported" to schools has meant Barnet has to give schools a bigger increase than that which we have received from the Government. In the light of all this, difficult decisions have had to be taken over services. There is some good news in that block cleansing and the Town Keeper Service will be extended and the Graffiti Removal Service increased. The Neighbourhood Warden Service is to be merged with Neighbourhood Management to create a new service that can handle a fuller range of quality of life issues.

The new Council CCTV centre will be officially opened on February 26th and among the areas covered is North Finchley. The Council is opposing Ken Livingstone's plans for the North Circular road at Henly's Corner and supports the original scheme that was approved at Public Enquiry. A Council Scrutiny Committee with an independent panel of experts has been set up to investigate the sale of the freehold of Barnet Football Club.

Frith Manor School rebuild

Following the devastating fire during the summer holiday, a new classroom block has been erected in the lower playground. While offering bright, warm and spacious rooms for the 210 children using that part of the school, this is a temporary facility pending the construction of a building fit for the needs of a primary school in the 21st century.

There was a welcome morning, held in early October, to mark the opening of the new classroom block. Councillor Coleman promised parents that the Council was committed to rebuilding the school and that we would not be left with any of the current freestanding huts. A team of Council experts is working with members of the school community to ensure that this plan becomes a reality.

School governors and staff have been busy visiting a number of newly-built schools to gain ideas and learn from the experience of others.

Consultation is under way to establish a priority list of facilities to meet the needs of both the school and local residents. This is important because a demonstration that the school will be used by the local community out of school hours, would add support to the funding of the rebuilding project. Letter from the Chairman – a personal view

The few weeks that Partingdale Lane was opened were sufficient to show that the road does serve a useful purpose and now that it has closed again, roadworks have again appeared at the Bittacy Hill roundabout and the traffic is back to its normal standstill. Those of you who supported the re-opening of Partingdale Lane may be required again to vocalise your support otherwise the tiny minority of people who want the Lane to remain closed will take precedence over the vast majority and our, so-called, democratic society loses out again.

Council Tax is rocketing this year by some 25% and we are told that no provements to Council services will ensue. Councillors readily blame each other but the fact of the matter is that Barnet Council is inefficient, over-bureaucratic and embroiled in pointless forums, meetings, consultations and expensive legal battles including Partingdale Lane and the debacle of Barnet Football Club all of which cost substantial amounts of money. There is no doubt that the constant search for ultimate democracy, which is supposed to involve every living soul in the Borough but actually involves less that 5% of the population, costs the Council a great deal of time and money.

I am not for one moment decreeing that the Council should be run by a dictator - some would say that it is, but that is just press propaganda. Democracy should surely be utilised by the majority and not just the few who often have nothing better to do than cause havoc within the Council corridors. The problem is that we are the silent majority who say nothing. Is it not time that we voiced our disapproval about the spiralling Council Tax? Is it not time that we examined the machinations of Barnet Council and ascertained where all of this money goes? If things carry on in this way, we could be paying £10,000 per year for an average house by the year 2012.

Council News - a report from Councillor Brian Coleman

The big set piece occasion of the year in the Council chamber was the budget debate that took place on March 4th wher the Council tax was set for the year 2003/4. The increase (including the GLA precept) is just over 23% - slightly by than what was predicted in December, but still a significant rise. The Council had to take a view after the poor gran settlement for the Borough how much to raise council tax and how much to reduce services. There are reductions in the economic regeneration, tourism and central services budgets among others but the Council has protected front line especially street-based services. Schools budgets have been maintained but schools have suffered the withdrawal or central government's "standards fund "money. A Best Value Review of the Council's public affairs department has lead to a reorganisation and significant savings.

A new design for road name signs has been introduced that includes the Borough coat of arms and will be slowly rolled out, as signs need replacing.

The former Leader of the Council, Councillor Alan Williams has decided to retire as Leader of the Opposition or the Council.

Extensions – a proposed code of practice

As part of the Association's new Extensions Guide (see below) the committee is proposing the adoption of the following code of practice for members and their contractors, in addition to the practices required by the legislation and the by-laws. The recommended practices are:

- to pave over no more of the front garden than is necessary to avoid regular street parking;
 - to preserve or replace trees and shrubs;
 - to discourage the use of pavements and front gardens for the storage of building materials and
 - to urge contractors to control their activities so as to avoid the unnecessary escape of dust and debris;
 - to monitor the dumping of materials and the parking of contractors' vehicles so as to preserve access by neighbours and passers-by;
 - not to permit contractors to park vehicles or dump equipment or materials on grass verges.

Partingdale re-opening postponed

The final re-opening of Partingdale Lane has been postponed again because of a procedural dispute between some of its residents and the Council. In response to a temporary cour injunction, the lane was closed for the second time or February 3rd. The injunction was granted because the procedures used to re-open the lane were considered to have been contrary to the Council's constitution. The courts no jurisdiction concerning the merits of the decision to re open: that is a solely a matter for the Council.

Towards the end of March the court is to rule finally upon the correct procedure to be followed. When it does, we expect the Council to re-open the lane without further delay.

In the meantime we may expect a continuing stream o propaganda from those who hope to persuade the Council to keep the lane closed. We should all consider writing to the press about it - especially those of us who had enjoyed decades of trouble-free walks and rides along the lane in the years before it was first closed.

Letter from the Chairman – a personal view

Besides the battles in Iraq, there has also been the ongoing "Battle of Partingdale Lane". Due to the rather more important battles elsewhere in the world, the Battle of Partingdale Lane never actually made the national headlines, although the seemingly biased local press have no hesitation in filling their paper with much pro-closure propaganda. It seems strange to me that, despite the wishes of the vast majority of people, the road still cannot be re-opened.

Our Councillor, Brian Coleman, has been woefully maligned and misrepresented for his dealings with Partingdale Lane. Consequently, a few people have been able to block the democratic process. We masses need to rise p and let our views be known. It seems unlikely that the American army will rescue us (or the British Army for that matter) and we therefore need to openly support Messrs Coleman and Co., whose grenades and rocket launchers appear to have been temporarily removed by the courts whilst snipers in Partingdale Lane continue to take pot shots at them.

Since the last newsletter, we have been researching the astronomical Council tax rise and whilst I still think that there is good deal of wastage (and overpayment of executives) within the Council, it does seem that the rises have mostly been due to outside pressures from the GLA and similar bodies who have all demanded increased revenues. Conversely (or perhaps perversely) the Central Government grant has been reduced because of an apparent decline in the population within the Borough, highlighted by the 2001 census. On the basis that we do not live in Iraq, I find it very difficult to believe that 30,000 people have just "disappeared" in the past decade, especially as the number of dwellings has increased. I reach the inevitable conclusion that the census must be wrong. Westminster Council somehow managed to misplace 64,000 residents and has suffered a similar experience to Barnet. However, Westminster say the census understates their population because thousands of their missing residents never eceived census forms or were incapable of filling out the forms. Did this nappen in Barnet as well?

The Cheese and Wine Party was a success but it would have been more rewarding to have seen a few more new faces. Our thanks go to the Old Finchleans who allowed us to use their premises free of charge. Do attend the AGM and put 2nd June in your diary. The AGM should last ten minutes and. afterwards, you will then have an opportunity to put profound (and possibly deeply disturbing) questions to Councillors and Council representatives.

Council News - a report from Councillor Brian Coleman

Partingdale Lane aside, the Council has been dealing with a wide agenda in the last few weeks. The Council agreed amendments to the Council Constitution which means that full Council meets monthly (rather than 6 weekly) and will include questions to Cabinet Members; and the Council Policy Conference, which had no executive powers and was considered by many Councillors just a talking shop, is scrapped. There are no changes proposed at the moment to Area Forums.

The Cabinet have agreed a new graffiti policy that increases the areas in which free removal is offered to private landowners and guarantees 48-hour removal in town centres.

CCTV cameras are now operational in East Barnet and Hampden Square.

The Council, in conjunction with Enfield, is taking Transport for London to judicial review over the abandonment of the previously agreed North Circular Road schemes.

The Cabinet have agreed a "loan" scheme to help schools with this year's difficult budge. However, teacher redundancies are still likely. The Secretary of State, due to the borough's "exceptional difficulties", has agreed this and yet when we asked for more funding to cover "exceptional difficulties", we were refused.

Funding Approved for Frith Manor School

Funding has been approved for the rebuilding of Frith Manor School and the designs are well under way. At long last the outdated huts will be replaced by modern buildings in which to provide the children with the latest facilities and technology. The new school buildings will include a nursery and a new dining hall and kitchen, Facilities are also to be made available to the community. Construction will be in two phases with the first phase beginning in July.

"This is a once in a lifetime opportunity to build a new school with wonderful facilities to support not only the learning of children aged three to eleven, but also with the potential to support on-going learning of all in our community," said headteacher Reg Herring. "Frith Manor is keen to involve all interested parties in the planning stages of our new community school: pupils, parents, staff, and of course, local residents. The changes that are about to take place at Frith Manor will affect many generations of Woodside Park residents for years to come.'

A representative from the architectural team will make a short presentation and answer questions at the Woodside Park Forum on 2nd June.

Cheese and wine evening

All who came found the cheese and wine evening held in March to be an enjoyable occasion, but attendance was down. £137 was raised for the North London Hospice by a raffle of prizes donated by Sussex Ring shopkeepers. The next evening is being planned for September.

Partingdale Lane – a further delay

A judge has ruled the re-opening of Partingdale Lane to have been unlawful because Councillor Coleman did not have an open mind on the matter. Other accusations of procedural impropriety were rejected. The judge appeared not to have taken account of the Association's petition against the original closure, nor of the fact that users had not been consulted before the road was closed.

The Council have decided to challenge the implied restriction upon the implementation of election promises by lodging an appeal.

Censored!

We sent this to the Hendon and Finchley Times

(without the bold type and underlining)

Mel Simpson seems to believe that the petition by Woodside Park residents was considered before Partingdale Lane was closed ('Lane closure resulted in fewer accidents', Letters April 24). In fact the Lane was closed without consulting any of them.

The consultations between the Council and the Partingdale Lane residents to which he refers, established that the Lane's accident record did not meet the Council's criteria for expenditure on safety measures. The London Accident Analysis Unit's records show that in the seven years before the Lane was closed there were only three casualties caused by accidents there. No pedestrians were involved and there were no serious injuries. This confirms the experience of the many Woodside Park residents who used the Lane regularly for decades without incident.

(In order to claim that there were 16 casualties, Mr Simpson had to add a number which occurred in Frith Lane and the Ridgeway, including accidents having no connection with Partingdale Lane.)

Accidents in the surrounding area may have fallen since the Lane was closed (depending how "the surrounding area" is selected), but there is no evidence to justify Mr Simpson's claim that the reduction resulted from the


By any objective measure Partingdale Lane has a better safety record than many of the borough's other roads - many of whose residents would also welcome their closure.

We were pleased to see the high attendance for the AGM and Forum and thank you to everyone who attended. Assertive and, indeed, somewhat tricky questions were thrown at the Forum's guests covering a multitude of items - but high on most people's agenda was Partingdale Lane which is covered elsewhere in this newsletter. We were also advised about the new plans for Frith Manor School which, regrettably, did not include a child drop-off zone.

Surprisingly, other than a few side remarks, no-one mentioned the hike in Council Tax and, as seems to be the way of things, we all seem to have meekly accepted the rise as inevitable, shrugged our shoulders and moved on to greater things. Did you realise that something like 75% of earned income disappears in tax in some form or the other. We are being taxed from all directions these days and I wonder how long we are just going to sit back and let it happen.

One issue, raised at the Forum, related to early morning refuse collections. Many of us now receive three collections a week, one for house refuse, one for garden refuse and one for recycling. This would have been unheard of a year ago and we ought to congratulate the Council on this service.

However, the collections seem to start at about 7am and, when you couple this with low-flying aircraft, police sirens, car alarms, burglar alarms, fireworks, etc., trying to have a decent night's sleep these days seems to be impossible. The noise of aircraft is particularly disturbing. They seem to fly at night until about 2am and start again just after 5am. The government is talking about increasing the number of runways in London thus causing even more aircraft movement. Sometimes, I look up and see all of these aircraft zig-zagging across the sky (which has been remarkably blue lately). They seem to be so close to each other.

Tag-merchants have scrawled more graffiti just recently. An eagle-eyed Association member actually caught the culprits on camera and our congratulations to him for being so alert. More about this overleaf.

Partingdale Lane: - the *Times* denies bias

Its Group Editor does not consider that the Hendon and Finchley Times gave the appearance of bias when, for example, it described Partingdale Lane as a "rat run", nor when it said that "another more serious accident is only a matter of time away". He says that the former is a fact and that the latter was only a comment on the Council's road safety policy; and that the only issue they had ever taken an editorial line on in relation to Partingdale Lane was the council's role in relation both to the democratic process and road safety issues. He complains that the Woodsider has made a one-sided assault on his newspaper's reputation.

Partingdale Lane: - a resident's description

"Partingdale Lane is a pleasant country lane a little over half a mile long, bordered by fields and woods along part of its length. It is in the Green Belt. Along other parts of the lane there are houses. The houses are built on the edge of the road and we step from our houses into the lane..."

Council News - a report from Councillor Brian Coleman

The Council met in June with Councillor Melvin Cohen in the chair as Mayor of the borough and discussed the issue of the shortfall of school budgets. The Government finally admitting that the borough has "passported" all the money it was given on to schools, the problem rests in Government under-funding, which they may correct next year. The secondary schools which have budget difficulties include Copthall, St James Colindale and East Barnet.

The cabinet has agreed the largest-ever public consultation exercise over the future of the site of Park House in East Finchley where Waitrose wish to build a new supermarket and public library. Residents may be interested to know that the road on which the new Waitrose in Mill Hill is situated in "Langstone Way" is named after the late Cllr Barbara Langstone, a popular local figure.

The Council has granted planning permission for the new Frith Manor School (including a nursery) and work should begin in the late summer. The new Controlled Parking Zones in North Finchley and Church End have come into operation and the Council will monitor any effects on Woodside Park. Discussions on the future of Darlands nature reserve continue, with no final decisions having been taken. Finally, in a colourful ceremony and parade at the Town Hall, the borough formally adopted the sea cadet unit TS Broadsword in recognition of all they do to organise remembrance ceremonies.

A record Woodside Park Forum

Following the AGM and a presentation on the rebuilding of the school, this year's Forum was a lively event attended by over 80 members. On the panel were Councillor Victor Lyon (Ward Councillor and Council Leader), Chief Superintendent Sue Akers (Barnet Borough Commander, Metropolitan Police), Councillor Brian Coleman (GLA and Ward Councillor), Reginald Herring (Head Teacher, Frith Manor School), Inspector Tony Scott (Head of Barnet North Sector, Metropolitan Police), Steve Presland (Head of Environmental and Neighbourhood Services), and Sara Lord (Neighbourhood Management Coordinator, Chipping Barnet). There were questions on Partingdale Lane, police resources, graffiti, school admissions, speeding, litter, recycling boxes, parking on grass verges and the closure of the gate at the end of Walmington Fold.

Members present demonstrated a near-unanimous wish for the early re-opening of Partingdale Lane. The Council's withdrawal of its appeal against the court order closing the lane would enable a new consultation to be conducted in the near future, which would cover a wide area of Totteridge and Mill Hill, including all of Woodside Park. The prospect for re-opening would depend upon the response to that consultation.

Barnet had not gained any additional police officers

from this year's allocation, but seven Police Community Support Officers (PCSOs) had been recruited and it was intended to raise that number to 30 by the end of the year. (PCSOs wear different uniforms from police officers, and have more limited powers.) They would work closely with police officers and neighbourhood wardens. The CCTV cameras at Tally-ho had scored some success against graffiti vandals and a mobile CCTV unit was shortly to come into service. Further action was to be taken against local graffiti perpetrators. A new Beat Officer would shortly be appointed following the posting of PC Gavin Philp.

It is intended that places will be available in September at Frith Manor School for all children for whom applications are made by parents living in the Suburb. Discussions were continuing about the introduction of a walking bus to escort children to the school, with pick-up points at Sussex Ring and Cissbury Ring.

Consultation letters were to be issued concerning proposals to place small posts to discourage parking on the grass verges in parts of Chanctonbury Way, and there would be a joint approach to the golf course management by Council and Association officers concerning the gate at the end of Walmington Fold.

The AGM

After the Chairman's review of the year, the Treasurer reported a record subscription total of £722, bringing the surplus for the year to £193 and leaving a balance of £834. The main outgoings had been a net loss of £91 on the cheese and wine evening, and £185 spent on the Christmas tree and its insurance. Robert Shutler was re-elected Chairman, and Nick Gardner and Fred Westphal were re-elected Secretary and Treasurer. Following the resignations of Marilyn Kendall and Therese Jones and the co-option of Estelle Phillips, the other members of the committee were confirmed as Stephen Coulson, Simon Goodwin, Elizabeth Kendle, Jonathan Ladipo, Estelle Phillips, John Robinson, Kiyotaka Suzuki and Jacqueline Weiner.

Letter from the Chairman – a personal view

High summer temperatures and balmy evenings have turned the grass brown but fortunately we seemed to have avoided water shortages this year and for this we should perhaps be grateful. And, as the new building known as the Tallyho Artsdepot becomes a huge blot on the landscape and snarls up the traffic, let us hope that the autumn will be equally warm and that this carbuncle (to quote Prince Charles) has some decent form of external cladding which will make it appear somewhat less ugly than at present.

Whilst on the subject of blots on landscapes, the Association has submitted an objection on your behalf to a planning application by T-Mobile to install a 12m high telephone mast outside 14-17 Sussex Ring to serve the new 3G networks. To some extent, I do not object to the mast itself which appears fairly similar to a lamp-post except for the three aerials on top. It is the large equipment cabinet which accompanies the base of the mast that I find rather difficult to swallow. These things are needed if we are to progress in this world and improve communications still further. The vast majority of us do, after all, use mobile phones these days although I do not suppose that many of us have yet moved onto the new 3G system where the new phone does just about everything except water the garden. There is, of course, the question of microwaves, etc. about which I am not qualified to comment. Objections or letters of support can be sent to the Council. ref: N13830/03.

People in Folkington Corner who complained to me about the state of the road and pavement will, I hope, be pleased to see that something is being done at last. We applied a little pressure on the Council and it seems to have worked.

The summer months brought the usual spate of graffiti, yobs and itinerants. Most disturbing, was the appearance of a rather scruffy vagrant down by Riverside Brook who hung around the children's play area and hid in the bushes. Despite protestations to the police and the Council about this person, the authorities have been unable to finally resolve the matter. Unfortunately, the man's appearance and demeanour make him seem rather menacing, although he may be quite harmless. It seems strange to me however that we have to wait until he does something awful (which he may not of course) before any action is taken. Allowing people to sleep in the streets and to mix with the community as a whole is a matter which needs careful re-consideration by the authorities.

The Partingdale Lane Consultation

Following last April's High Court decision, a further consultation concerning the future of Partingdale Lane is to be conducted this Autumn. Its results are to be reported to Barnet's Cabinet next January and it is expected that a decision will then be taken. The scope and form of the consultation are still under discussion between the Council and the consultants who have been engaged to carry it out. Early indications are that a wide area of Totteridge and Mill Hill will be covered, and our guess is that a range of options will be included. The launch of the consultation may be expected to prompt a resumption of a media lobby organised by MI Simpson and his Resident's Association.

Council News - a report from Councillor Brian Coleman

Several issues have occupied the mind of the members of the Council's Cabinet in recent months including the ongoing issue of schools funding. No more money has been forthcoming from the Government and with some imaginative accounting, all bar two secondary schools have agreed budgets for the current year with the Council and action is being taken to ensure the remaining two do so soon.

The Government has agreed that all our Council housing should be vested in a so-called ALAMO (Arms Length Management Organisation.), the Board of which will include Councillors, tenants and representatives of the community.

Those of you who are regular shoppers at North Finchley will have noticed that the pelican crossing on the High Road near the junction of Lodge Lane has been restored to its original position to improve access and egress to Lodge Lane car park. The dangerous cycle lane on the pavement has also been removed.

To coincide with the start of the autumn term and the introduction of "walking buses" and other measures under the Council's Safe Routes to School programme, new waiting restrictions will come into force around Frith Manor School, aimed at reducing congestion and encouraging more children to walk to school.

Kidz Conga - A new bus service for Woodside Park

There will be a new bus service operating on weekdays in Woodside Park beginning this autumn. The bus will be non-polluting, won't take up precious space on our already crowded roads and won't even charge its

The 'Kidz Conga', Frith Manor's walking bus is due to debut by early October. Parent volunteers have been police checked and trained by Local Authority officials before beginning their new healthy method of transporting school children to Frith Manor School. The initial Kidz Conga will travel the 1/2 mile route from Sussex Ring up Lullington Garth to the school. Children registered for the walking bus can be taken to the meeting point at Sussex Ring where they can be checked in with a volunteer, so avoiding the need for them to be taken to the school by car.

Children on the Kidz Conga will be able to develop their road safety skills, improve physical fitness and arrive alert and on time to start their school day. Various incentives will be offered to the children including baseball caps and certificates awarded in assembly.

Parking spaces outside Frith Manor School will be at an even greater premium this autumn as the Council's experimental parking restrictions come into force. As a result of complaints by the bus company and the emergency services over badly parked cars outside the school, new parking restrictions will be in force between 8 and 9.30 am and 2 to 4 pm every weekday beginning this autumn.

It looks like the new walking bus couldn't have come at a better time. Good luck to the Frith Manor Kidz Conga!

The 2003 Membership Survey

This year, committee members called on each of the 859 houses in the suburb and spoke to members of 86% of their households (the other houses were empty or their residents were out). Subscriptions were collected from 94% of the households that were contacted - bringing in a total of £629. Asked what topics the Association should tackle in the coming year, there were replies from 28% of households. Of those who replied, 46% said they wanted Partingdale Lane re-opened (as compared with 0.2% who said they wanted it kept closed); 15% wanted less graffiti; 14% wanted less litter; and 11% wanted something done about dog fouling. The remainder of those who replied were mainly concerned about crime, traffic I safety, the tennis courts, or the condition of the roads and pavements.

Council News – a report from Councillor Brian Coleman

The October meeting of the Council considered a number of matters including recycling, where the Council welcomed the improved rates being achieved in Barnet (16% of domestic waste) but urged residents to greater efforts so that the Government targets (18% in the current year) can be achieved. The Council also heard an announcement on the creation of over 200 new nursery school places (including Frith Manor) and welcomed the opening that afternoon of the extension to Moss Hall Nursery School.

The Council also endorsed the Community Plan (not to be confused with the Council's own Corporate plan!) produced by the Civic Forum and covering many of the same issues, including fear of crime and clean streets. The Council also heard an emergency statement from the Leader (Cllr Lyon) on the actions the Council was taking to alleviate problems caused by the Camden Town derailment.

Contrary to some stories in the local press, the Borough Police Commander and the Council are at one on the introduction of an alcohol-free zone in North Finchley, and the experimental zone should be in operation before Christmas.

No Mast at Sussex Ring?

The Council has refused the application to install a mast and consul at Sussex Ring on the grounds that The proposal by reason of its size, height and siting would be visually intrusive and detrimental to the appearance of the street scene.

Our thanks to residents who supported the Association's opposition to the application by writing to the Council. We are told that individual letters have more influence than petitions if there are enough on them. Attendance at planning committee meetings is probably even more effective, but was not necessary this time because the application was dealt with by officers, using the powers delegated to them by the Council. We do not yet know whether Marconi plan to appeal against the decision.

Extensions without tears

If you are planning an extension, please remember the Association's code of practice:-.

- · pave over no more of the front garden than is necessary to avoid regular street parking;
- preserve or replace trees and shrubs;
- discourage the use of pavements and front gardens for the storage of building materials and tools;
- urge contractors to control their activities so as to avoid the unnecessary escape of dust and debris;
- monitor the dumping of materials and the parking of contractors' vehicles so as to preserve access by neighbours and passers-by;
- stop contractors parking vehicles or dumping equipment or materials on grass verges.

The bollard and speed tables outside Frith Manor School have been removed to give better access to contractors' vehicles during the school rebuilding. When the rebuilding is finished, there will be a review of the case for traffic-calming measures. In the meantime, vehicle-activated signs are to be installed in Lullington Garth. They will flash Slow Down! warnings at motorists who exceed the speed limit.
