It links areas of public open space along the valley of Dollis Brook, a tributary of the Brent, that rises near Arkley. It passes through Barnet Gate Wood (an ice age forest remnant), Totteridge Fields, the parks and paths of Woodside Park and under Mill Hill viaduct and provides many habitats for plants and other wildlife. It is well worth a walk on a lazy, hazy summer Sunday afternoon. Ahh!! Those heady days!!

Council News - a report from Councillor Brian Coleman

Barnet Council recently met to set its Budget and Council Tax for the forthcoming year after much deliberation and significant further savings in Council expenditure across the Board, the final Council Tax rise (which includes a freeze in the GLA precept) is 2.1 %. An Inquiry into Councillors and he has resigned with immediate effect. Negotiations are ongoing on the recovery of Barnet's (and 120 other Councils) deposits. The Council is close to signing a lease with the Herts and Middlesex Wildlife Trust over the Darlands nature reserve which will preserve the (after a London wide telephone vote) and your Totteridge Councillors will ensure that the Woodside Park stretch of the Dollis Brook receives appropriate improvement.

The public exhibition of the Mill Hill Inglis Barracks plans has taken place and, as far as I am concerned, the plans are a long way off being acceptable to me.

I have been elected by the Council to serve as Mayor of the London Borough of Barnet for the Civic Year 2009/10 taking office on May 19th with my Mother as Mayoress and I look forward to continuing to support the Community in Woodside Park in that capacity.

You knew that Barnet has lots of attractive open spaces, but did you know that one of the most beautiful is (almost) on our doorstep? Its nearby residents have persuaded the Council not to signpost it, so not many people know it's there. It is the Darlands Lake and Nature Reserve, which lies deep in the Totteridge valley – fed by the same Folly Brook that flows behind Chanctonbury Way. It can be reached by walking across the fields beyond the Woodside Park Club and past Ravensdale School, but it is easier to find it by looking for a white five-barred gate just beyond the Orange Tree pub on Totteridge Lane. Alongside it is a kissing-gate leading to a public footpath. Go down a long tree-lined path and around the lake, and you will see all sorts wild flowers and wild fowl. In the Spring there are masses of daffodils, bluebells and the rare snakes-head fritillaries, but it is a delight at all times of the year.


The police are rather too busy not catching MPs to be reporting on crime in the neighbourhood—so there is no report.

I was delighted to be elected as a Councillor for Totteridge Ward at the by-election on 4th June and should like to express my thanks to all those who voted for me. Having grown up in the Buckinghamshire countryside, I moved to Totteridge nearly thirty years ago just after I got married. One of the main reasons I love living in this area is the wonderful open spaces, park and green belt. I particularly enjoy walking up to the Long Pond, strolling around Darlands Lake and cycling along the path by Dollis Brook. When I was canvassing back in the Spring, I was amazed by the number of people I met who cited the open spaces as the most important reason why they had lived here so long. When our daughter was little, I used to spend many happy afternoons with her at Swan Lane Park, although unfortunately the cafe did not exist then! Your Councillors have been asking for some new play equipment to improve the park and have just been told that it should be installed by the Spring.

As a Councillor, as well as being involved with local ward issues, you are also given a number of committees to sit on - some of course more interesting than others! One of the ones I have been appointed to is Health Overview and Scutiny. FOUR DAYS IN BARNET GENERAL HOSPITAL

An inconvenience experienced by Estelle M. Phillips (in convalescence)

Walking a Labrador, on a bright sunny Saturday afternoon in July, I was uprooted and floored, when, in a nano-second, she spotted and started chasing a cat. Prostrate on the ground, I rescued my mobile. In great pain, I managed to call an ambulance which whisked me off to Barnet General Hospital. After seeing a doctor and having an X-ray, my arm was put in plaster, I was given mega-doses of painkillers and an appointment for the fracture clinic on Monday morning.

Monday could not have arrived soon enough and I was seen by an orthopaedic surgeon who informed me that I needed surgery. I felt scared. The last time I was an in-patient was 35 years ago. I had a bad night at home with my memories ... the pre-med that made my mouth dry for at least an hour before surgery; counting backwards from ten and struggling to save myself from suffocation as an anaesthetic mask was put over my face just a little too soon and waking up with a bucket beside my bed into which I could vomit during recovery. Missing the bucket was not an option!!

I soon discovered that things have radically changed. It was necessary for Barnet General to liaise with the Royal Free about a pre-existing condition and I was told to return the next day. In those 24 hours, the Royal Free advised the surgical team at Barnet about specific concerns; obtained items which might be required for emergency use in the operating theatre and even telephoned me at home to let me know what arrangements had been made. I was very impressed and pleasantly surprised by the coordination between the two hospitals in two different boroughs and two separate Primary Care Trusts..

I was admitted into Barnet on Tuesday and operated on the next day. I was in theatre for 75 minutes having a metal plate and wire inserted into what was left of my wrist. I was then in recovery for several hours being given more mega-loads of drugs to keep me relatively pain-free and on an even keel, even though I began to remember things that never happened!

I stayed in hospital for a further 36 hours. During that time I cannot fault either Barnet General Hospital or the NHS. My treatment, food, room, etc. were all excellent.

One week later I had my post-operative check-up and it was all good news. The skin is healing well. I have soluble stitches so there are no worries about having them removed. The surgery was described as 'beautiful' and the metal plate and pin are doing whatever they are supposed to be doing with my bones. As a result I have been put into a glove instead of a lighter plaster which means I can remove it to shower and perform light wrist exercises which, hopefully, will remove the need for physio when I return for further assessment in a month's time.

All this is way beyond what I had been told to expect. Well done and thank you to the NHS. But.....whoever said that a dog is good for your health?

Crime Report


Very little crime has occurred in the area of Woodside Park over the past few months, except for what are loosely described as "notifiable offences" which covers broader issues such as domestic disputes, noisy youths and disputes between neighbours. We are rather fortunate to suffer the lowest crime rate in the Borough of Barnet. In the twelve months up to June 2009, the Borough registered 26,179 reported offences including, one homicide, 53 rapes, 2,689 residential burglaries, 5,013 violence against persons and 4,184 motor vehicle crimes. Barnet police closed down nine cannabis factories just recently.

Crime is just around the corner and we should not be complacent. There have been a number of cases of rogues knocking on doors and preying on the vulnerable and the elderly. As good neighbours we should keep an eye on these people. Do not get involved but do call the police if anyone suspicious and without proper identification arrives at your door.

We enjoyed a record attendance at the Old Finchleians Clubhouse and Geoff behind the bar was his usual cheery self, ensuring that those who wanted to be plied with drinks departed suitably inebriated.

We were blessed by the presence of Theresa Villiers (our local MP) and all three of our Councillors - all on expenses-free trips!! And we raised quite a substantial sum of money for the Mayor's Charity Appeal this year. We were ably and loudly entertained by Johnny Lawrence who added a certain something to the occasion. I am not quite sure what that something was maybe deafness!! I believe that the term for the architecture is "contemporary" but the construction is rather cheap and nasty and in ten or twenty years time when the elevations have deteriorated, we will wonder why the Council allowed such development.

There is a certain irony to all of this. I have discovered that Inglis Barracks was named after Lieutenant-Colonel

William Inglis of the 57th Infantry Regiment who died in 1811. Long before Bruce Willis was conceived, he coined the phrase "Die Hard" which was the last order to be given to troops before an attack. Did the Council not die in a whimper?

But are we going to allow this to continue? Well, we should try and fight our corner. Many of you will have received a letter from the Council advising about the new planning application which has been made by the so-called Inglis Consortium - which is St Modwyn's in another guise. This is an "outline" planning application, so it does not deal in such matters as scale, layout, appearance and landscaping all of which have been reserved for a future application. This application deals with the nitty-gritty of the site, for example - how many houses, how much commercial space, how much retail, how much park, etc. The application runs into some thousand or more pages of waffle and gobbledegook, much of which is incomprehensible to any sane person. The cameras were rolling in Chanctonbury Way in August when filming took place for an advertisement for Aviva. Some impressive driving and specifically parking entertained the residents and Aviva were kind enough to contribute to our funds as well.

Council News – a report from Councillor Brian Coleman

Within the last few days, your Totteridge Ward Councillors have received the long awaited and much feared planning application for the Inglis Barracks site. This 1000 page application has now gone out for consultation to residents and local groups and will be decided by the Council's Planning and Environment Committee on a date to be decided after Christmas, although the public consultation closes in mid December. Following a decision of the same Committee to approve the massive Cricklewood/Brent Cross planning application (despite my personal appearance as London Assembly Member to argue for refusal) by eight votes to one with one abstention, I am not optimistic about the outcome. I, personally, along with Councillor Richard Cornelius and Councillor John Hart of Mill Hill Ward, will oppose the application for Inglis Barracks as it stands. Councillor Alison Cornelius, as a member of the Planning and Environment Committee, cannot declare a position in advance of the Committee meeting. I strongly urge residents to read the summary of the application and make their views known.

Consultation has also begun on next year's Council Budget with the level of Council Tax rise likely to be of the order of 1 or 2 per cent. Boris Johnson has frozen the level of precept from the Greater London Authority for the second year running.

As Mayor, I was delighted to attend the Annual Woodside Park Garden Suburb Residents Association social evening and was most grateful for the substantial proceeds of the raffle which were donated to my Mayor's Appeal for the Larches Trust and Resources for Autism, two local charities supporting people with learning difficulties within our Borough.

Inglis Barracks Over-Development

You will have received a letter from the Council advising you about an outline planning application which is being made by the Inglis Consortium. You will also have been invited to comment by 17th December 2009. Before you can comment, it is important for you to actually understand what is being applied for which is not made very clear in the Council's letter to you. The application asks for approval for 641 one-bedroomed flats. 966 two-bed residential units, 390 three-bed residential units, 239 four-bed units and 38 five-bed units. This equates to residential space for up to 6763 people. The application does not include the Annington site which comprises 360 residential units for around 1500 people, nor the existing Notting Hill Housing Association site of 72 residential units (275 people) nor the Bittacy Court site of around 100 units (500 people). We were originally advised under the Area Action Plan that the site would cater for 2660 residential units for around 5000 people. This application increases the number of units to 2906 residential units and the population to 9038 people. In addition, the application asks for approval for some 11,840 sq ft of retail space, 37,351 sq ft of office and light industrial floor-space, 5,700 sq ft for a GP Surgery, approx 37,000 sq ft for a primary school and 6,781 sq ft for an Energy Centre (which we believe is not large enough for a nuclear power station!). The retail space will employ about 50 people, the school could employ 50 people, the employment space can employ 1800 people, the surgery 20 people and the energy centre 4 people. There could therefore be around 2000 people employed on the site. There will be around 3000 car parking spaces.

The developer tells us that the additional population of 11000 people might generate some extra 400 car movements during the peak rush hours. What nonsense. There will be gridlock. Is there anyone out there who can help us interpret the Transport Report attached to the Application? We really would appreciate some help. The developer has taken the Council's Area Action Plan and essentially added 10% to the proposed development and 100% to the proposed population. This application only deals with the outline of the site. When the detail is applied for it is guite possible that another 10% will be added.

If you want to object to the application, you should do so on the planning grounds that it does not comply with the approved Mill Hill East Area Action Plan. Put this in the first paragraph of your letter to the Council and then give all of the other reasons you can think of to back this up.

Crime Report

The Metropolitan Police has now decided not to send out any figures regarding local crime. Instead, we receive figures which are fairly meaningless and have no specific reference to our immediate area. It is not possible to even interpret these figures in any way without having the historical set.

We congratulated the police at the time for a really good initiative on their part. Now they have gone backwards.
