Letter from the Chairman – a personal view

Happy New Year to everyone!!

Thank you to those who have contributed to the Association's coffers with donations to help with our enquiries and research about the proposed development at Inglis Barracks. It is much appreciated.

I should also like to thank everyone who attended the Carol Singing. It was very cold that day and we all had to wrap up warm but, nevertheless, some seventy people turned up. My special thanks to Colette who led the singing, to Brian who played the organ and to young James who played the recorder. Without any rehearsal they played tightly (and, quite often, magnificently in tune) – well done!! I must also thank Blakes for providing the electricity and water and the Association's committee and aides, without whose help these events could not take place.

Barnet Council provides us with countless services, many of which we do not physically perceive nor, indeed, understand — especially when buried in bureaucratic confidentiality. What we did recently observe was snow, lots of it, great big fluffy dollops of it - all over our roads and pavements. What we didn't see was road and pavement gritting, clearing away the snow from the side roads and walkways, services for which we pay huge amounts of Council tax, services which are supposed to be provided by the Council but for reasons (not fully explained) were not. And so, people get injured on the pavements and vehicles get damaged on the roads.

How can the Council run out of salt and grit? In a time of crisis, the Council failed us.

Of course, this was a good excuse not to collect our rubbish. Mine was not collected for three weeks and in some areas of our suburb, no collections were made for four weeks. Bins were left on the pavements in the vain hope that the refuse collectors might turn up - but they did not.

And our Council failed us again.

Perhaps these issues are not so serious (unless you have been injured or hurt in the snow), but the Council has gravely failed us regarding the huge amount of housing that is being thrust upon us in the borough - which has not exactly been opposed by those we voted into power.

It seems we have no choice. No political party has offered to resist this absurd growth in housing which is based on historically unreliable census figures and incorrect data.

Barnet is being forced by the Government and the GLA to accept some 25000 to 35000 new homes in the Borough before 2016 (these figures vary depending upon whom you talk to). We were initially under the impression that Boris might help to reduce these figures to a more manageable level - but the opposite seems to be true. He has now condoned the principle of an additional 49000 sq ft of commercial space (for 500 jobs??) and 2660 homes proposed at Mill Hill East. Furthermore, he has placed unwieldy financial demands upon the developers who will simply ask for more intense development to pay for it.

The Inglis Barracks development has been enshrined in the unilaterally approved Mill Hill East Area Action Plan and the developers have now put together an outline planning application for the site.

You should have received a letter from the Council regarding a public meeting to be held to discuss the matter further. If you are interested in the effect these proposals will have on our community you should please make the effort to attend. The more people who attend, the more it will be realised by the power-that-be that this is a matter to be taken seriously — especially with elections looming.

# INGLIS BARRACKS PUBLIC FORUM

### INGLIS BARRACKS MIS-DEVELOPMENT

The developers have made an outline planning application for a comprehensive redevelopment of some two-thirds of the Inglis Barracks site. An outline planning application is not a full planning application. This means that only certain elements of the development are being dealt with at this juncture. This outline application is requesting permission in respect of "access to the site" with all other matters of layout, scale, appearance and landscaping reserved. These matters will be dealt with at a later date when a full planning submission is made. The full planning submission will be loosely based on the outline planning permission and it is quite possible that the full planning permission will amend previous consents as the scheme is more fully designed and as more financial burdens are placed on the developers by the various public bodies. A series of parameter plans accompany the application showing indicative land use, scale, landscaping, site levels strategy and character areas.

Herein lies the problem. Everything (except the redevelopment of the Officer's mess into ten flats) is indicative - which means it is simply showing what "might or could be". What "might or could be" at this stage often "isn't" at the full design stage, which makes commenting in a meaningful way at this juncture very difficult. This is a subterfuge used by the big developers to lull us all into a false sense of security. We saw this happen with the Annington Homes section of the site and we have ended up with the unsightly, disjointed mass which is now rising on the Frith Lane/Partingdale Lane corner and beyond.

The proposed development will apparently comprise a total of 2174 dwellings, a primary school for 500 children, GP surgery, 1100 sq m (11,840 sq ft) of commercial uses (shops, etc.), 3470 sq m (37,351 sq ft) of business employment uses, a district energy centre and associated open space. To the above you need to add the 360 Annington dwellings (being built at present), the existing and retained 72 Notting Housing Trust dwellings (off Bittacy Hill) and the existing and retained 49 Bittacy Court dwellings (south of the railway bridge in Frith Lane) and the existing warehouses and commercial space by the railway.

All of this could generate an extra 10500 people to the area, 3169 car parking spaces and therefore 3169 cars, 2,000 or so cyclists, goodness knows how many extra rush hour traffic movements, traffic jams, bedlam and general dysfunction. The attitude seems to be "build the development first and sort out the problems afterwards".

The scheme is very complicated and there are some 1300 pages of documentation to wade through, much of which is incomprehensible or based on figures plucked from somewhere or the other which, unless you are an expert, is impossible for the individual to countermand. For example, there are hundreds of pages of traffic generation formulae which are based on some specific examples elsewhere. For every example used by the developer, it is quite possible to find examples which counteract the statements upon which all of these calculations are made. As residents in the area, we do not believe these people when they tell us that very little extra traffic will be generated - when there are some 10500 extra people using the area. What total hogwash!! This is the problem. Patently the developers would not care about us and the mayhem this is going to cause, the Government certainly doesn't care about us, Boris doesn't care and neither do the Council.

If you know anything about traffic management and generation, please contact us because we could really use your help.

This will affect you and you should, if possible, attend the public meeting and making your feelings felt. You can check out the application on the Council's website and you might also wish to make your feelings known to our local Councillors and our MP. Lastly, you should write formally to the Council to express your views in accordance with the letter you will have received from the Council. Always put the Council reference on your letter in this respect.

Letter from the Chairman – a personal view

The same applies to most other issues. Nothing much will change at local levels mainly because most of what happens of any major significance is decided at the moment by central government. There are lots of ideas at local level (most of which I do not usually agree with) but none of these ever seem to come to fruition. I gain the distinct impression that local politics is run by the civil servants and central government.

Take the Mill Hill barracks site. It was decided by the GLA that Mill Hill should be an area of high density housing and this was backed by central government. The Council had little say about this although I still believe that they could have delayed everything a lot longer. But this has been going on for about ten years now so I do not know how much longer it could all have been delayed. Anyway, the Council had to choose about having some input or none at all and, wisely, I suppose, they decided to have some input which, at least, allows us to have some say. However, the atrocious architecture presently being thrust upon us is the result of a central government inspector's decision.

Apparently, even because there was hardly any road gritting when the snow arrived and there are, even now, still potholes in the road, this is a direct result of central government interference in expenditure.

I am hopeful that whoever is returned to power in central government will defray some real power back to the local levels. In the last thirteen years or so, government has become far too centralised.

### Woodside Park Garden Suburb in 1934 (contribution from Nick Gardner)

In 1934, the nucleus of what is now the Woodside Park Garden Suburb was a compact and mainly self-sufficient community. There were no buses and very few cars and the residents shopped mainly at a cluster of shops at the junction of Lullington Garth and Walmington Fold. Those included a grocer, a butcher, a baker, a greengrocer, a tobacconist/newsagent, a chemist/optician, a hairdresser, an off-license, an ironmonger, and the "Little Shop" which sold wool and haberdashery. The suburb then comprised roads in a semicircle to the west of the shops. Cissbury Ring was open fields, and Walmington Fold did not extend further south than number 48. The new Finchley golf course adjoined the suburb to the south. Fields to the west were used for grazing by the Express Dairy. It was possible to walk north across the fields to The Orange Tree. Frith Lane was just a track and the only road access to the suburb was from Nether Street down Argyle Road into Lullington Garth... Access to the park was through a locked gate to which all residents had keys - now there's an idea.

### Council News - a report from Councillor Brian Coleman

The dust from the elections has now settled both nationally and locally . Whilst a Conservative/Lib Dem coalition was required to form a Government, locally the Conservative Party increased its majority on Barnet Council winning 39 seats. Labour won 21 seats and the Liberal Democrats 3. In Totteridge Ward, Councillors Richard and Alison Cornelius and I achieved a substantial increase in our majority and are deeply grateful to all residents who voted for us. We will continue to serve the best interests of Woodside Park for the next four years. Having retired as Mayor of Barnet, I have returned to the Cabinet in charge of the Environment with a particular mission to sort out the state of the roads, (expect some early good news on this) I am also the Conservative Chief Whip. Councillor Richard Cornelius continues to be Cabinet Member for Housing and Regeneration but takes on Planning Policy as well, whilst Councillor Alison Cornelius takes the Chairmanship of the Health Committee. It will not come as a surprise that the Council will have to take some difficult and painful spending decisions in preparation for next year's budget when the Council Tax will again be frozen.

Early noises from Central Government are encouraging with announcements about ending housing and traveller site targets (although not yet in London), scraping housing density rules and protecting gardens from so called "garden grabbing". On the Health front, all reorganisation proposals suggested by NHS London have been rejected by the new Secretary of State and they have been sent back to the drawing board. Theresa Villiers was appointed Minister of State for Transport with a particular brief for London Transport and Crossrail and in the Dissolution Honours list was appointed a Privy Councillor.

Your local Councillors continue to hold their surgery for residents on the third Saturday morning of the month at Barnet House.

### The Local Elections - on standing as an Independent Candidate

(from the offices of Dr Estelle M. Phillips)

Ten weeks before the May elections, I saw an announcement inviting people who were unhappy with our Council to a meeting. I attended the RAB (Residents Association of Barnet) inaugural meeting and heard several people speaking about their frustration with the current situation. They were saying what I had been thinking. At a follow-up meeting I tentatively entered my name to stand for election in Finchley Church End ward where I had lived for many years prior to moving to Woodside Park.

I had no idea of how to proceed or what I was letting myself in for. I paid my dues to RAB and procured ten signatures in the obligatory black ink from residents in the electoral ward to register. An Agent, introduced by RAB, was appointed to help complete the very bureaucratic forms. Eventually, the Returning Officer informed me that my nomination was accepted. I was now an official candidate for the Council elections. Barnet Council organized a half day training course for first time candidates which was both useful and interesting.

Meanwhile, RAB candidates had to provide an introductory electoral address complete with photograph. This was the most expensive and frustrating part of the whole experience as the initial printing was useless. There was considerable delay before the second printing arrived. My house was bedecked with boxed paper all of which had to be folded and made ready for depositing through letterboxes. I walked miles covering every street in my ward posting the folded flyers into letterboxes, many of which chewed at my fingers and restricted access to less than a centimetre. Low level, back-breaking letterboxes mingled with boxes concealed behind doorknockers and hidden in prickly bushes. Many blocks of flats had no access at all.

I had expected help from RAB volunteers but this did not happen. However I did collect two volunteers of my own as a result of leafleting. They, together with friends, helped me cover most properties on the electoral roll and I even managed to speak to some of the electorate. People were extremely friendly and supportive and I had no bad experiences at all during my weeks of leafleting.


I was at the polling station on election day. Numerous people turned up at the wrong station or with postal votes complaining that only one of the two postal voting forms had arrived. The next day I went to the count and spent several hours watching and interacting with other candidates, some of whom were 'old hands' at the game. Quite a number of forms were incorrectly filled out or spoilt in some way. However, the ruling was that if the voter's intention was clear then the paper was included. Finally, the various wards were called and the relevant candidates went onto the rostrum while the Returning Officer called out the results in alphabetical order. I felt very privileged to be part of this experience and learned a lot about how the system works.

Ten long weeks had elapsed from reading about the RAB meeting to the final results. I feel satisfied that my own results were quite respectable. I received slightly more than the other RAB candidates in my ward and together we beat the Green Party, which has been established for years. We are disappointed that not a single RAB candidate was elected. Next time perhaps.

I hope you enjoyed your summer vacation – if you could afford one. If not, at least we've had a hot (tish) summer here in the holiday resort that can be Woodside Park!

I was thinking of writing something long and verbose about the Barnet Councillor's self-awarded gratuitous pay rise but, just as I wrote something, they seem to have backed off (for the time being). They must have known that I was just about to go on the attack!!

Nevertheless, it is true to say that the role of the Councillor has changed quite dramatically in the past ten years or so and, whereas it used to be a voluntary service to the community, it is now seen as a vocational post. Given the amount of gobbledygook emanating from civil servants in the Government and the Council, being a Councillor is virtually a full-time job. I have to sometimes read these documents myself and they are incredibly long-winded and tedious.

What I did find astounding, however, was how the Barnet Councillors could have so completely misjudged public opinion. Can the increased majority have gone to their heads already? You may recall that, in the last Newsletter, I asked residents

to let me know if any crimes were committed in the area that they knew about. The police have decided not to tell us about this and it was my intention to keep you informed via the Newsletter. I have been notified of three burglaries in February (two in Walmington Fold and one in Cissbury Ring South) and nothing since. I am hoping this is true, in which case we are indeed fortunate to live in an area with such a low crime rate.

Your committee does their best to maintain a sense of sobriety in the area. In Woodside Park, we are indeed fortunate. We have trees, we have grass verges, we have gardens, hedges and greenery. We have narrow streets and wide streets and we have houses which mainly have some architectural merit although some people are selfishly trying to undermine our heritage by constructing hideous extensions. We have no restrictions to parking in the street and we are served well by public transport. We have the brook and the park and a children's play area. We can enjoy walks across the fields and adjacent green belt. We have local neighbourhood shopping and local schools. Furthermore, the house beyond my rear garden is also extending. And so I endure much noise, dust and disturbance with nothing (not even an improved outlook) to show for it at the end. You see, my former owners did extend a couple of rooms into the garden in the 1960's so I don't need more rooms right now. Surveyors, one from my owner and another from the adjoining house, have looked me over from top to bottom, inside and out. I have been measured, photographed and commented upon.

There is so much banging and noise from so many directions. The other day I really thought a whole wall in my bedroom was going to fall down. My garden is not so peaceful any more either. Because two separate houses are involved, both the back and front parts of me have people working high up. Sometimes they throw things down and I'm really worried that something will land in my garden. Luckily, they seem to be pretty accurate with their aim.

Oh yes, I almost forgot the house on the other side of me (the one I share a driveway with) has just been sold and that has never had any work done on it at all - so ------

### **Shared Drives and Party Walls**

Very few houses remain in Woodside Park that have not been extended in some form or the other. As a Residents' Association we do not generally object to extensions, although we do draw the line at two-storey side extensions which cause a "terracing effect" in the street and "pretend sheds" in rear gardens which seem to end up housing the maid, granny or even another family.

With regards to side extensions, neighbours need to check their freehold documents. In the suburb, freehold documents were often drawn up to give the neighbour a right of way in perpetuity over the space between the two houses, even though the land does not belong to the neighbour. This is not a planning issue but it is a legal issue. The freeholds in Woodside Park were set up precisely to prevent the terracing effect which you sometimes see when houses are extended at the side. If you are planning a side extension you should check that you are legally allowed to do this.


If your neighbour is proposing to build a roof extension or a rear extension, the chances are there should be party wall award. Failure to provide such an award can lead to a dispute which can, in turn, affect the value of your property and your neighbour's property.

Good neighbours always consult their neighbours before commencing building works.

### Council News -a report from Councillor Brian Coleman

Detailed work continues on Barnet Council's budget for 2011/12 although the level of grant from the Government will not be known till early December. There are going to be considerable cuts following the comprehensive spending review announced by the Government in October. In order to protect services to the vulnerable and to keep any rise in Council Tax below inflation, there may well be reductions in Arts funding (particularly the unpopular Arts Depot), some reorganisation of Libraries and Museums and a concentration of Children's "Sure Start " centres in areas of the Borough where they are really needed. The parking service currently run "in-house" is to be privatised and the "future shape "programme is budgeted to provide £100 million of savings over the next 10 years.

Following the successful completion of the "Pot hole elimination Programme" Barnet's roads are in good condition to face the winter weather and there is plenty of salt in store at the Mill Hill Depot!

Meanwhile, consultation has been started by the Metropolitan Police Borough Commander on the future organisation of Safer Neighbourhood teams as the Police Authority struggles with a reduction in its budget.
