Letter from the Chairman – a personal view

The weather seems to have been very wet so far this year but now, coupled with the recent sunshine, Woodside Park is looking very green and lush. Hopefully, the rain will leave us for June onwards and we can all properly enjoy the drought!

After the May elections, we have a change in representative on the GLA. Andrew Dismore is now the new representative for Barnet and Camden. The outgoing GLA representative, Brian Coleman, has served us well and we thank him for all his help and assistance over the past eight years. Whatever you may think of Brian Coleman, he has been a staunch supporter of Woodside Park and the people who live here. Brian retains his position as our local Councillor. We shall wait and see if Andrew Dismore has the same passion for this part of London.

One of the successes Brian Coleman achieved whilst on the GLA was to secure the funds to refurbish the Dollis Brook walk and the children's playground on Riverside. Activity in this area has increased dramatically. Cycling on the footpath in Riverside is not permitted and yet cyclists are continuing to pedal furiously along the footpath. It is only a matter of time before an accident occurs. There have already been some close calls. If you see cyclists using the footpath perhaps you can please gently remind them that cycling is not permitted. The community police have promised to patrol the footpath more regularly but they have very little power so we have to rely on the considerate behaviour of the cyclist (something often to be found lacking - especially if they are wearing lycra!).

We are going to be suffering from roadworks galore over the next year. The Government has decided that everyone should have water meters. This is typical of the present government - dealing with issues in a negative way. The positive way would have been to put forward plans so that we will all have more than enough water in the future. No chance! And the local gas supplier has decreed that everyone must have new gas mains. The new mains, etc. are already being installed down Frith Lane and Chanctonbury Way.

Better news is that the new Finchley Memorial Hospital is close to completion and should open in September this year.

We are organising the Riverside Summer Festival on Sunday 1st July 2012 to raise funds for the playground extension and eventual all weather sports surface. Please see attached flyer. Do come along and support us – from 12 noon until 5pm.

I should like to thank the parents and children of Frith Manor Primary School who raised close to £1,000 towards the proposed playground extension. Well done to all involved. 100% of everything donated goes to the playground equipment. I had to give a little speech to the children at the school and have never been so nervous!! Hundreds and hundreds of little faces looking up at me in bewilderment! Our future, bless them!

Everyone is allowed to run a business from home these days as long as the business does not start to encroach on local neighbours. I have received a number of complaints from people and I am particularly referring to the larger commercial vans and vehicles which seem to have appeared over the past few months. These vehicles park in the narrow streets, usually on pavements which are supposed to be for pedestrian use. Whoever these vans belong to, do you think you could try parking them on the wider streets and not on pavements, grass verges and the like failing which we are going to have to start examining the planning issues involved here. All it needs is a little consideration for others.

A night of Horror (written by Estelle M Phillips)

For the first time ever, I was forced to use the Emergency 'out of hours' phone line to call a doctor in the middle of the night. Of course I know that the days when one could expect to see one's own doctor in an emergency regardless of the hour are long gone. However, I did (naively perhaps) believe that if I used the Emergency out of hours phone number to call a doctor I would be treated as though I had a reason for calling for help in the early hours of the morning. Not so. Instead of the instant response I thought would reassure me, alone in the house, I was kept waiting online for 25 minutes and I was getting more and more scared that my condition was worsening. Because the automatic answer-voice kept repeating, very apologetically, that the team knew I was waiting, I didn't dare hang up to call an ambulance in case a human being hopefully medically trained - would come to the phone at any moment. I waited, minute by slowly passing minute, for the full 25 minutes until a receptionist spoke to me and took details. I was told that I would be called back by a nurse in 10 minutes. I had no choice but to hang up. I was very tired, in addition to being frightened.

It must have been the case that when the nurse heard about me she decided to wait no longer, as I was called back almost immediately. We had a reasonable and professional discussion at the end of which she gave me the option of either calling for an ambulance right away or waiting about three hours for a doctor to visit me. From then on things improved. The doctor phoned every hour to check on me and eventually arrived, as promised, three hours from the time the nurse had spoken to me. When I told her of the useless inefficiency of the emergency contact number she was shocked. She insisted that this should not happen. But it did happen. What is the use of BarnDoc's emergency nightline if somebody can begin by being able to call and report a problem but not be answered until they have become almost totally incapacitated? The emergency doctor was excellent but the emergency out of hours telephone number is a disgrace and should certainly be investigated and scrutinized by those with the knowledge and authority to improve this very important (but currently useless) facility.

The Changing face of Woodside Park

Permitted development planning laws have radically changed the appearance of many houses in the suburb from that originally envisaged by Mr Fred Ingram, the Suburb's founder. Gable ends, rooflights, extensions in every direction and the loss of front gardens to car parking - all have decimated the original concept. The houses are now generally larger and more suitable for modern living. Pitched and hipped rooflines have been lost forever and many properties are comparatively ugly, although this is in the eye of the beholder. Most of the houses have been built with 225mm thick brickwork external walls which, in thermal loss terms, are very poor. You can insulate the roof and install double glazing but if you line the walls internally with 200mm thick insulation, the space lost is huge and people are understandably loathe to do this.


The latest government guidelines are suggesting that walls are insulated externally and there may be grants or other incentives available to do this in the due course of time. Insulation will take the form of 200mm (or more) thick board which can be rendered externally or covered with timber boarding, plastic sheeting or some other material. The linings will affect the depth of the eaves and the roofs and the whole look of the houses in the suburb. This appears to be inevitable given that the government is committed to reducing greenhouse gas emissions by 70% by the year 2050. It is hard to imagine the suburb full of rendered houses (rather than brick), with little or no overhang to the roofs, off-street parking throughout and very little planting. But this is what will happen in the future.

And so we have the wonders of greening the country. Rather ironic I think. Let us hope we can at least keep the trees and grass verges but the way some people treat them, this is unlikely to happen as well. Welcome to the concrete jungle. Is this what is called progress?

Council News

We did not ask the Councillors to write anything this month because the Council is embarking on its "One Barnet" policy whereby much of what is presently carried out in-house is going to apparently be sub-contracted to external services run by private companies. In doing this, the Councillors maintain that they will cut costs, cut bureaucracy and have greater efficiency, which will be to the benefit of the residents in the Borough of Barnet (unless you happen to be very young, old, infirm or incapacitated).

The problem for the Council, at present, is that it is tied to all sorts of labour limitations and restrictive practices which emanate from the good old days but have never moved forward with the times. Hence the union, UNISON, is kicking up one hell of a fuss about it and frightening the living daylights out of everyone with stories of despair and horror.

If the services are to be sub-contracted out, the contracts need to be properly and decisively written by professional people who know what they are doing. Remember the G4S fiasco with the security for the Olympic Games? Like the Government and LOCOG, and despite employing many people earning more than £100,000 per annum, the Council are apparently incapable of doing this – so what do they do? Of course - they sub-contract it out! Great! Forgive me if I lose the will to live.

Inglis (Mill Hill) Barracks

The old warehouse building has been demolished and there is now a flat-tish site. The developer is starting to put the main infrastructure in place. In addition, they are digging up Frith Lane like there is no tomorrow for new gas mains to serve the site and the neighbourhood. No doubt, they will be digging up Frith Lane again for the electrics and then, later on, for the water.

In the meantime, the developers of Inglis Barracks are ploughing through the ninety-two conditions attached to their planning permission and they have applied to the Council to discharge the requirements for conditions 26 (pedestrian and vehicular access points), 48 (open space design), 52 (children's play space) and 65 (contamination remediation verification report). None of this looks very much different to that originally proposed and so we have made no comment in this respect.

Woodside Park Industrial Estate

We are glad to learn that some of those people who parked their large vans and lorries on the kerbs in Woodside Park have now left the area for pastures anew. Woodside Park is not meant to be an industrial estate and should not be treated as such.

The last newsletter contained a comment about the inconsiderate parking of commercial vehicles in our leafy suburb. Through our website, www.woodside-park.com, (check it out!) we received the following email from an angry gentleman residing it Lullington Garth:-

"I find this amazing, considering the number of inconsiderate drivers who park their cars badly and sometimes partly blocking my drive. There have been numerous times when I have had to leave a note on a car because of the way they have parked in front of my house, virtually making it impossible for me to come out of my drive. What is worse is when they park their box of a car smack bang in the middle of a parking area so that nobody can park in front or behind them.

So maybe these petty minded people who have all the time in the world to go around complaining about business vehicles should get a life and learn to park their own excessively large cars properly.

The worst offenders are the mothers who drop their children off to school. Then they are so tired that they have simply got to go and join the other mothers for a coffee. We believe that this meeting will serve to give more information to those of us who will be affected by the new approach and also to stimulate discussion about it.

15A Pyecombe Corner	Single storey building in rear garden
49 Cissbury Ring North	Single storey side and rear extension, new pitched roof over garage
81 Cissbury Ring South	Roof extension, rear dormer and three rooflights to front for loft conversion

If you decide to pave over your driveway, please consider the environment and ensure that the paving is porous or that a soakaway is provided. Please also provide a bit of greenery.

If you decide to implement permitted development of your house, it is a good idea to tell your neighbours what you are proposing. This really can save difficulties and misunderstandings later.

ONE BARNET

If you are concerned about the level of your Council Tax, you should attend the "One Barnet" meeting which we have organized at Frith Manor School. See above. The meeting will be in the form of a Forum with the two speakers stating their cases and then questions from the floor. It is important that you are acquainted with what is being proposed.

As is the way with all things concerned with the Council, a garrulous and longwinded amount of information can be found on their website under:-

Crime is on the rise. There were eight burglaries in the area in July 2012 and nine in August. 90% of the burglaries were through the rear of the property. Car theft is also on the increase but there are no figures for these. Thieves also seem to be able to open cars with remote controls - so do not leave valuables in your car.

As if the thieves are not bad enough, motorists need to be further aware that the police are out and about with speed guns, especially on Longland Drive and Totteridge Lane. They are also now instructed to issue tickets to drivers who park inconsiderately (and about time too!)
